Tuition Assistance Program (TAP) 2019-20

TAP provides modest financial assistance to families who meet income guidelines. Each year, the actual number of awards and the total amount given varies based on available funds, overall enrolment and the level of participant need.

How to apply

Once you are enrolled in our Early Learning Center, you may submit a TAP application.

Eligibility considerations

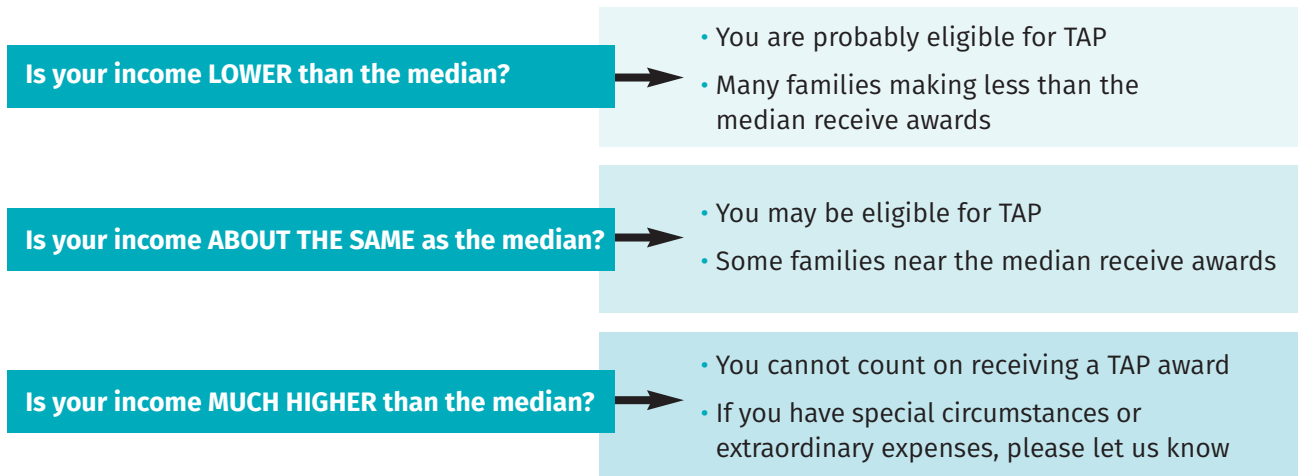
Step 1. Find your own family size on the chart below.

These are the median incomes for Massachusetts. We use these as a base to determine TAP eligibility.

Family of 2	\$77,394
Family of 3.....	\$95,605
Family of 4	\$113,815
Family of 5.....	\$132,025
Family of 6.....	\$150,236

Step 2. Compare your own family income from all sources to the income chart shown in Step 1.



Awards are based on financial need, but families are always expected to pay the majority of tuition costs.

A good rule of thumb is to make sure you could afford 85%-90% of the tuition.

Frequently Asked Questions (FAQs)

What materials do you require, in addition to the TAP application?

For income verification, you must provide a copy of your 2017 or 2018 tax return with your application. If applicable, proof of current participation in an income eligible state or federal sponsored program replaces the need for income verification.

If you are arriving from abroad for temporary employment or a fellowship, you must submit a letter from your new employer stating your income.

I need a great deal of financial help. What should I do?

If you cannot envision yourself paying at least 85%-90% or more of tuition, you may have a difficult time paying for tuition at the JCC. You might consider a reduced schedule. How does TAP get applied?

Tuition assistance applies to your contracted tuition at the JCC Early Learning Centers.

ELC tuition assistance can be applied to ELC summer program, only if you are also enrolled for the school year.

I am recently unemployed – which income figure will you use?

Please indicate your newly unemployed status clearly (including the duration of your unemployment) on the application and we will take this into account.

Can I get my deposit back if I don't get enough tuition assistance?

The deposit is not refundable.

My income is high, but I also have a lot of expenses. How does this factor in to the decision?

Because every family makes choices about how to manage expenses such as housing, cars, vacations, education, personal debt, home renovations, and leisure activities, we do not take these things into account. However, if you have an unusual circumstance (medical, unemployment, special education, elder care, foreclosure or adoption expense, etc.) that you would like us to consider, please let us know on your application.

Do I get the same amount every year my child(ren) is enrolled at the JCC?

If your family income is similar, we try to keep the award percentage as level as possible pending JCC budget availability. Please note that tuition generally rises over time. Even if you receive the same tuition assistance percentage, your child care expenses are likely to increase.

How are decisions made in years where demand exceeds available funds?

We aim to provide award assistance to families at or below the Massachusetts median income.

Who is funding the JCC Tuition Assistance Program?

The JCC is committed to affordability and TAP is funded solely through tuition income.
