

JCC GREATER BOSTON CAMPS "JCAMPS": TERMS AND CONDITIONS

Thank you for choosing JCC Greater Boston Camps "JCamps": Camp Grossman & JCamps Newton (Kaleidoscope & Newton Specialty Camps) and School Break Camps for your summer and school year programming. We look forward to sharing camp with your child for the 2026 season. Please read these Terms and Conditions carefully. By registering your camper, you agree to all of them.

PAYMENT POLICIES

Deposit: Camps Grossman and JCamps Newton require separate deposits for each session or week. The deposit(s) are strictly tied to those specific sessions and/or weeks. A deposit of \$75 per week is due upon registration. Sessions or "plus weeks" for summer camps may be dropped or switched, pending availability, without loss of deposit until February 1. Campers enrolled in School Break Camp pay tuition in full at the time of enrollment and all enrollment is final with no refunds.

Registration Fee: A \$36 per camper annual registration fee will be charged at the time of enrollment and is not refundable or transferable (including School Break Camp campers). A camper pays this registration fee one time annually (September - August) regardless of the number of programs enrolled in. As of April 1, the registration fee increases to \$136

Early Bird Rates: Early Bird rates are valid thru 12/31 and apply to TUITION only. Any enrollment additions or changes after 12/31 will be at the regular 2026 tuition rates.

For Camp Grossman, after 12/31 there will be a \$25 per week fee added for any camper who chooses car as mode of transportation for the summer.

Important Payment Dates for all Summer Camps:

After February 1: Deposits are no longer refundable or transferable. For example, to switch from Session 1 to Session 2, the Session 1 deposit will be forfeited.

February 1 until April 1: Sessions* or weeks may be dropped, and all fees paid will be refunded EXCEPT for the registration fee and deposit(s). *Sessions may not be split to drop individual weeks. For example, for a switch from Session 1 to Plus Week 1, Session 1 must be dropped, the entire Session 1 deposit will be forfeited, and then Plus Week 1 (with its associated deposit) is added.

April 1: Families are financially responsible for all sessions and/or weeks for which they are registered. Any outstanding fees will be collected in accordance with the previously selected payment plan option unless written notice to withdraw/unenroll has been received by April 1.

Tuition: There are 2 payment options available at the time of registration. You can elect to pay in 2 installments (in February & April) or via a monthly payment plan (with the first installment processed in February). You must select your payment option at the time of registration. Any registration submitted after May 15 will require full payment by June 15. Payment of camp tuition is accepted in the following forms: Check, Electronic Funds Transfer (EFT) and Credit Card*. *Convenience fees may apply based on payment method. If you elect to pay by physical check, please note that payment must be received and processed before the installment date to avoid having that payment charged to the method on file.

Bank Service Fee: A \$25 processing fee will be added to your invoice for any check or EFT returned unpaid or credit card declined.

Discounts: One-time sibling discounts of \$50 for the 2nd and each additional sibling will apply. JCC Members with active family memberships also receive special pricing (each session is discounted by \$50). A change in JCC Greater Boston membership will result in adjusted rates after review at the start of the summer.

Financial Aid: Financial aid applications must be completed online in your CampInTouch account before February 1, at which time all submitted requests will be reviewed. Requests made after February 1 will be reviewed individually and are dependent on the funds remaining. Awards are not guaranteed year to year or for weeks added after February 1. If you are unable to accept the award, you must submit a written request to either reduce enrollment or withdraw. You must submit this request within 2 weeks of award notification to receive a refund of any deposit(s) connected to the withdrawal. Additional weeks can be added after the deadline has passed, however, there is no guarantee that the aid will be the same. Financial aid is awarded by each camp program and is not transferable between camps.

Waitlists: If a spot opens on the waitlist, the next camper in line will automatically be enrolled, with the deposit taken from payment info on file, and the family will receive notification. Families have 1 week to decline the spot for a refund of the associated deposit. Families may remove their name from the waitlist by emailing the appropriate camp at any time before a spot is offered.

Refunds: Tuition is non-refundable after April 1; this includes no refunds for illness, partial weeks or sessions attended or changed plans.

FAMILY HANDBOOK

I have (or will) read the Family Handbook(s) relevant to enrolled programming and agree to abide by the policies contained within the Family Handbook(s). The Family Handbook(s) will be made available by or before February 1. Any questions related to policies within the handbook(s) should be directed to camping@jccgb.org.

TRANSPORTATION

Families will be provided with camp pickup passes which can be shared with anyone authorized to pick up a camper. Parent(s)/legal guardian(s) listed in CampInTouch are authorized by default to pick up. During registration, families may indicate authorized individuals beyond parent(s)/legal guardian(s) who are authorized to pick up and may request to update if necessary. Camp staff may also ask to see identification for pickup.

LATE PICK-UPS

Any camper picked up beyond the expected pick-up times (either at camp or from the bus stop) will be assessed late fees in accordance with the camp specific policies outlined in the Family Handbook.

CLOSURE POLICY

If a JCC Camp must close your child's bunk, or all of camp, due to an unexpected single-day closure such as excessive heat, power loss, state or local guidance, or other unforeseen safety circumstances, JCC Greater Boston will not issue refunds. We appreciate your understanding as we prioritize the safety and well-being of our campers.

ILLNESS

Keep children home if they are not feeling well. Campers with a fever will not be admitted to camp. Campers who develop a fever or other symptoms of illness will be sent home. Campers must be fever-free without fever-reducing medication for at least 24 hours before returning to camp. Campers are asked to follow precautions and regulations related to viruses, infections, respiratory illnesses, or other communicable diseases, which may be updated based on current conditions. Parents are expected to arrange a prompt pickup of any child who is ill.

EXPECTED BEHAVIOR

Camp is an exciting, fun, sociable and nurturing experience. Campers are expected to be respectful of each other, counselors, and the facilities. Families are expected to be cooperative partners, completing paperwork fully and truthfully, updating Camp when there are changes, and communicating respectfully, as we will with you. While we make every effort to work with all accepted campers, any campers endangering themselves or others may be asked to leave camp. Refunds are not given to campers who are asked to withdraw. Parents may request a copy of the discipline policy at any time.

CAMPER READINESS

The camp environment requires more independence than most classroom settings, and most bunk counselors are teens/young adults, not trained teachers. Camp is not an early childhood program and is not recommended as your child's first independent group social experience. All campers should be able to enjoy a day full of activity without a nap. All campers must be able to dress themselves and use the restrooms independently. This includes the awareness and ability to vocalize the need to use the restroom, the ability to get to the restroom (often some distance from the group) with enough lead time, manage clothing, wiping, flushing, and washing hands to attend camp.

Household Participant Waiver, Indemnification of All Claims and Covenant Not to Sue

NOTICE: THIS IS A LEGALLY BINDING AGREEMENT. Read this document carefully and in its entirety. By signing this agreement, you give up your right (and where you are signing as parent or guardian on behalf of a minor child, the minor child's right) to bring a court or any other action to recover compensation or obtain any other remedy for any personal injury or property damage however caused arising out of your (or a minor's) participation in any programs or activities (collectively, "JCC Greater Boston Programs and Activities") sponsored or operated by or conducted at any facilities or on any equipment (collectively, "JCC Greater Boston Facilities") owned or operated by The Jewish Community Centers of Greater Boston, Inc. ("JCC Greater Boston") now or at any time in the future.

The words "undersigned" or "I" as used in this document shall refer to each person signing below as though each is signing a separate document. Where a parent or guardian signs this document on behalf of a minor child, the words "undersigned" or "I" shall include the minor child or children named below.

Acknowledgment and Assumption of Risk

The undersigned hereby acknowledges and agrees that participation in any of the JCC Greater Boston Programs and Activities or access to or use of any JCC Greater Boston Facilities comes with inherent risks. I certify that I have full knowledge and understanding of the nature and extent of the inherent risks associated with such participation and access, including, but in no way limited to: (1) personal injury, (2) property damage, (3) disability, (4) death, and (5) sickness or disease, including, without limitation, those caused by exposure to and infection with bacteria or viruses such as SAR-COV-2. I further acknowledge that the preceding list is not inclusive of all possible risks associated with such participation, access and use, and that said list in no way limits the operation of this Agreement.

I hereby certify that I am voluntarily assuming all the foregoing risks, including, without limitation, all risks associated with COVID-19. Without limiting the foregoing, I understand that I will be solely responsible for and assume the risk of any loss or damage, including, without limitation, personal injury, property damage, or death, I sustain while accessing or using any of the JCC Greater Boston Facilities or participating in any of the JCC Greater Boston Programs and Activities. I further certify that I am in good health and that I have no conditions or impairments, including any

conditions associated with COVID-19, which would preclude my safe participation in the JCC Greater Boston Programs and Activities or safe access to or use of any JCC Greater Boston Facilities, and/or the safe participation, access or use by other participants and JCC Greater Boston personnel.

Waiver, Release, Indemnification & Covenant Not to Sue

In consideration of the undersigned's participation in the JCC Greater Boston Programs and Activities and/or accessing or using the JCC Greater Boston Facilities, I hereby unconditionally release on behalf of myself, my heirs, representatives, executors, administrators and assigns, JCC Greater Boston, its officers, directors, employees, volunteers, agents, representatives, insurers and anyone working under, through or in connection with any of them (collectively with JCC Greater Boston, the "Releasees") from any liabilities, obligations, incidents, occurrences, causes of action, suits, claims, demands, losses, costs, expenses (including, without limitation, attorney's fees), property damage and personal injuries, including, without limitation, death, disability, contracted diseases or illnesses (collectively, "Claims"), of any kind, nature or description whatsoever, known or unknown, foreseeable or unforeseeable, in law or in equity, no matter how caused, which I, my heirs, representatives, executors, administrators or assigns may have, now or in the future, against any of the Releasees arising out of, on account of or in any way related to the access to or use of any of the JCC Greater Boston Facilities or participation in any of the JCC Greater Boston Programs and Activities, including, without limitation any travel provided to or therefrom, whether such access, use or participation is supervised or unsupervised, and hereby waive all such Claims and covenant not to sue any of the Releasees for any such Claims.

Each of the undersigned signing below as a parent or guardian on behalf of any minor child or children whose names are set forth below, certifies that each of the below named Minors is in good health and has no conditions or impairments, including any conditions associated with COVID-19, which would preclude the safe participation by the Minor in the JCC Greater Boston Programs and Activities or safe access to or use of any JCC Greater Boston Facilities, and/or the safe participation, access or use by other participants and JCC Greater Boston personnel. I further certify that I am the parent or legal guardian of the Minor with authority to sign this agreement. I further understand that the terms of this agreement are legally binding and certify that I am signing this agreement of my own free will after having carefully read it.

Each of the undersigned certifies that the date of birth set forth below my signature is true and accurate and that I am, therefore, of lawful age and otherwise legally competent to sign this agreement.
